He was on the Federal Aide Committee for The International Association of Fish & Wildlife Agencies (Working Subcommittee). He was also an Official Measurer for Boone Crockett, Pope & Young, Long Hunters Society and Safari Clubs International.

In his spare time, Fred was an accomplished naturalist and avid freshwater trout, saltwater and surf fisherman. He was also a voracious reader, a movie buff and a History and Discovery Channel fan.




